### Personal precautions, protective equipment and emergency procedures

### Methods and materials for containment and cleaning up

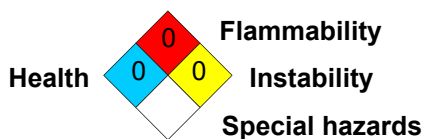
